

Attorney Visits – Federal Pre-Trial Holding Facilities

Must have for all jails: A current bar card and a driver's license or other form of picture identification.

Calhoun County Jail:

Shift change and meal times are the only off times for Calhoun County. The jail shuts down from 10:30 am to 11:30 am for lunch and from 4:30 pm to 5:30 pm for supper.

Shift changes and Count are at 7:00 am and 7:00 pm. Avoid these times for better results.

They will allow interns with Attorney visits as long as they have a valid driver's license or some other form of picture identification.

Cullman County Jail:

Breakfast is served from 4:30 am to 6:30 am/Shift change.

Commissary is passed out Tuesday and Friday from 6:00 am until 10:00 am.

Lunch is served from 10:45 am to 12:00 pm.

Dinner is served from 4:30 pm to 6:00 pm/Shift change.

Family visitations are scheduled primarily by the inmates and their families. Inmates should prioritize their attorney visits over social visits.

Interns are not permitted.

Hoover City Jail:

Breakfast is served from 4:00 am to 5:30 am.

Lunch is served from 11:45 am to 12:45 pm.

Dinner is served from 6:30 pm to 7:30 pm.

Sick Call is between 10:00 am and 2:00 pm, so if you know your client has issues, you may want to avoid this time until you know that your client has seen the doctor or the nurse.

Doctor sees the inmates on Wednesday, so the same above would apply if your client is having issues. This will prevent your client from missing a doctor's visit.

Interns are permitted as long as they have proper identification.

Morgan County Jail:

Saturday and Sunday:

9:00 am to 11:00 am

12:00 pm to 4:00 pm

Interns are permitted as long as they have proper identification.

If a special visitation is required outside these hours, call the Morgan County Jail at 256 351 4826 thirty (30) minutes prior to arrival to ensure that the inmate is available and an attorney room is available.

Pickens County Jail:

Monday thru Friday:

8:00 am to 11:00 am

1:00 pm to 4:00 pm

No attorney visitations on weekends or holidays.

There are no outlets available to charge laptops or phones.

Shelby County Jail:

Permitted visitation times:

Seven days a week:

7:00 am to 11:00 am

1:00 pm to 4:00 pm

6:00 pm to 10:00 pm

Shelby County will approve special visits upon request if it is a necessity. You can contact Jay Fondren at 205-670-6141 or Lt. Bedsole at 205-670-6207. If they cannot be reached, you can call Central Communications at 205-670-6066 and ask for a jail Supervisor.

They ask that if someone that isn't an attorney, but part of your legal team, ie paralegal or intern, that you call ahead of time to give them a heads up.
